AN INTRODUCTION

CLIMATE OF GHAZIABAD

Climate of Ghaziabad is more or less similar to that of Delhi. In Summer (March to October), day temperature goes up to 45⁰ C. The winter (November to February) temperature dips as low as 4⁰ C at night. Ghaziabad gets reasonably good rainfall.

REPORTING
